ANNEX- Definition of terms

DATA PROTECTION POLICY

1 Policy statement

- 1.1 Everyone has rights with regard to the way in which their **personal data** is handled. During the course of our activities Wright Robinson College will collect, store and **process personal data** about our pupils, **workforce**, parents and others. This makes us a **data controller** in relation to that **personal data**.
- 1.2 This information is gathered in order to enable it to provide education and other associated functions. In addition, there may be a legal requirement to collect and use information to ensure that the college complies with its statutory obligations.
- 1.3 Wright Robinson is committed to the protection of all **personal data** and **special category personal data** for which we are the **data controller**.
- 1.4 Wright Robinson College is registered, as a Data Controller with the Information Commissioner's Office (ICO). Details of the information held by Wright Robinson and its use are available on the ICO's website (Registration No. Z7501976).
- 1.5 The law imposes significant fines for failing to lawfully **process** and safeguard **personal data** and failure to comply with this policy may result in those fines being applied.
- 1.6 All members of our **workforce** must comply with this policy when **processing personal data** on our behalf. Any breach of this policy may result in disciplinary or other action.

2 About this policy

- 2.1 The types of **personal data** that we may be required to handle include information about pupils, parents, our **workforce**, and others that we deal with. The **personal data** that we hold is subject to certain legal safeguards specified in the General Data Protection Regulation (**GDPR**).
- 2.2 This policy and any other documents referred to in it set out the basis on which we will **process** any **personal data** we collect from **data subjects**, or that is provided to us by **data subjects** or other sources.
- 2.3 This policy does not form part of any employee's contract of employment and may be amended at any time.
- 2.4 This policy sets out rules on data protection and the legal conditions that must be satisfied when we process **personal data**.

3 Definition of data protection terms

- 3.1 All defined terms in this policy are indicated in **bold** text, and a list of definitions is included in the Annex to this policy.

4 Data Protection Officer

- 4.1 As a school we are required to appoint a Data Protection Officer (DPO). Our DPO is Victoria Duffy- contactable at v.duffy@wrightrobinson.co.uk (0161 826 1026). The DPO is also the central point of contact for all **data subjects** and others in relation to matters of data protection.
- 4.2 The DPO is responsible for ensuring compliance with the Data Protection Legislation and with this policy. Any questions/concerns about the operation of this policy should be referred in the first instance to the DPO.

5 Data protection principles

- 5.1 Anyone **processing personal data** must comply with the data protection principles. These provide that **personal data** must be:
- **Processed** fairly and lawfully and transparently in relation to the **data subject**;
 - **Processed** for specified, lawful purposes and in a way which is not incompatible with those purposes;
 - Adequate, relevant and not excessive for the purpose;
 - Accurate and up to date;
 - Not kept for any longer than is necessary for the purpose; and
 - **Processed** securely using appropriate technical and organisational measures.
 - be **processed** in line with **data subjects'** rights;
 - not be transferred to people or organisations situated in other countries without adequate protection.
- 5.2 We will comply with these principles in relation to **processing of personal data** by the college. We will only obtain such **personal data** as is necessary and relevant to the purpose for which it was gathered, and will ensure that we have a lawful basis for any **processing**.

6 Fair and lawful processing

- 6.1 Data Protection Legislation is not intended to prevent the **processing of personal data**, but to ensure that it is done fairly and without adversely affecting the rights of the **data subject**.
- 6.2 For **personal data** to be **processed** fairly, **data subjects** must be made aware:
- that the **personal data** is being **processed** and why;
 - what the lawful basis is for that **processing** (see below);
 - whether the **personal data** will be shared, and if so with whom;
 - the period for which the **personal data** will be held;
 - the existence of the **data subject's** rights in relation to the **processing** of that **personal data**; and
- 6.3 We will only obtain such **personal data** as is necessary and relevant to the purpose for which it was gathered, and will ensure that we have a lawful basis for any **processing**.

Personal Data

6.4 For **personal data** to be **processed** lawfully, it must be **processed** on the basis of one of the legal grounds set out in the Data Protection Legislation. We will normally **process personal data** under the following legal grounds:

- where the **processing** is necessary for the **performance of a contract** between us and the **data subject**, such as an employment contract;
- where the **processing** is necessary to **comply with a legal obligation** that we are subject to, (e.g. the Education Act 2011);
- where the law otherwise allows us to **process the personal data** or we are **carrying out a task in the public interest**; and

where none of the above apply then we will seek the consent of the **data subject** for the **processing** of their **personal data**.

Special Category Personal Data

6.5 When **special category personal data (i.e. medical, ethnicity, religion)** is being processed then an additional legal ground must apply to that processing. We will normally only **process special category personal data** under following legal grounds:

- where the **processing** is necessary for **employment law purposes**, for example in relation to sickness absence;
- where the **processing** is necessary for **reasons of substantial public interest**, for example for the purposes of equality of opportunity and treatment;
- where the **processing** is necessary for **health or social care purposes**, for example in relation to pupils with medical conditions or disabilities; and

where none of the above apply then we will seek the consent of the **data subject** to the **processing** of their **special category personal data**.

6.6 We will inform **data subjects** of the above matters by way of appropriate privacy notices which shall be provided to them when we collect the data or as soon as possible thereafter, unless we have already provided this information such as at the time when a pupil joins us.

6.7 If any **data user** is in doubt as to whether they can use any **personal data** for any purpose then they must contact the DPO before doing so.

Vital Interests

6.8 There may be circumstances where it is considered necessary to **process personal data** or **special category personal data** in order to protect the vital interests of a **data subject**. This might include medical emergencies where the **data subject** is not in a position to give consent to the **processing**. We believe that this will only occur in very specific and limited circumstances. In such circumstances, we would usually seek to consult with the DPO in advance, although there may be emergency situations where this does not occur.

Consent

- 6.9 Where none of the other bases for **processing** set out above apply then the college will seek the consent of the **data subject** before **processing personal data** for any other purpose using a consent form. When pupils/workforce join the college a consent form will be required to be completed in relation to them. This consent form deals with the taking and use of photographs and videos of them, amongst other things.
- 6.10 In relation to all pupils under the age of 13 years old, we will seek consent from an individual with parental responsibility for that pupil. We will generally seek consent directly from a pupil who has reached the age of 13, however we recognise that this may not be appropriate in certain circumstances and therefore may be required to seek consent from an individual with parental responsibility.
- 6.11 If consent is required for **any other processing of personal data** of any **data subject** then the form of this consent must:
- Inform the **data subject** of exactly what we intend to do with their **personal data**;
 - Require them to positively confirm that they consent – we cannot ask them to opt-out rather than opt-in; and
 - Inform the **data subject** of how they can withdraw their consent.
- 6.12 The DPO should be consulted in relation to any consent form before consent is obtained and a record of any consent will be kept, including how it was obtained and when.

7 Notifying data subjects

- 7.1 Wright Robinson will inform **data subjects**, via our privacy notices, that we will be obtaining information about them from third parties.

8 Adequate, relevant and non-excessive processing

- 8.1 We will only collect **personal data** to the extent that it is required for the specific purpose notified to the **data subject**, unless otherwise permitted by Data Protection Legislation.

9 Accurate data

- 9.1 We will ensure that **personal data** we hold is accurate, kept up to date, and will destroy out of date data.
- 9.2 We will take reasonable steps to amend any inaccurate data.

10 Timely processing

- 10.1 We will not keep **personal data** longer than is necessary for the purpose(s) for which it was collected. We will take all reasonable steps to destroy, or erase from our systems, all **personal data** that is no longer required.

11 Processing in line with data subject's rights

- 11.1 We will **process** all **personal data** in line with **data subjects'** rights, in particular their right to:
- request access to any **personal data** we hold about them
 - object to the **processing** of their **personal data**, including the right to object to direct marketing
 - have inaccurate or incomplete **personal data** about them rectified
 - restrict **processing** of their **personal data**
 - have **personal data** we hold about them erased
 - have their **personal data** transferred

The Right of Access to Personal Data

- 11.2 **Data subjects** may request access to all **personal data** we hold about them. Such requests will be considered in line with the colleges Subject Access Request Procedure.

The Right to Object

- 11.3 In certain circumstances, **data subjects** may object to us **processing** their **personal data**. This right may be exercised in relation to **processing** that we are undertaking on the basis of a legitimate interest or in pursuit of a statutory function or task carried out in the public interest.
- 11.4 An objection to **processing** does not have to be complied with where Wright Robinson can demonstrate compelling legitimate grounds which override the rights of the **data subject**. Such considerations are complex and must always be referred to the DPO upon receipt of the request to exercise this right.
- 11.5 In respect of direct marketing any objection to **processing** must be complied with.
- 11.6 Wright Robinson College is not however obliged to comply with a request where the **personal data** is required in relation to any claim or legal proceedings.

The Right to Rectification

- 11.7 If a **data subject** informs the college that **personal data** held about them by the college is inaccurate or incomplete then we will consider that request and provide a response within one month.
- 11.8 If we consider the issue too complex to resolve within that period then we may extend the response period by a further two months. If this is necessary then we will inform the **data subject** within one month of their request that this is the case.
- 11.9 We may determine that any changes proposed by the **data subject** should not be made. If this is the case then we will explain to the **data subject** why this is the case. In those circumstances, we will inform the **data subject** of their right to complain to the Information Commissioner's Office at the time that we inform them of our decision in relation to their request.

The Right to Restrict Processing

- 11.10 **Data subjects** have a right to “block” or suppress the **processing of personal data**. This means that the college can continue to hold the **personal data** but not do anything else with it. The DPO must be consulted in relation to requests under this right.
- 11.11 The college must restrict the **processing of personal data**:
- Where it is in the process of considering a request for **personal data** to be rectified;
 - Where the college is in the process of considering an objection to processing by a **data subject**;
 - Where the **processing** is unlawful but the **data subject** has asked the college not to delete the **personal data**;
 - Where the college no longer needs the **personal data** but the **data subject** has asked the college not to delete the **personal data** because they need it in relation to a legal claim, including any potential claim against the college.
- 11.12 If the college has shared the relevant **personal data** with any other organisation then we will contact those organisations to inform them of any restriction, unless this proves impossible or involves a disproportionate effort.

The Right to Be Forgotten

- 11.13 **Data subjects** have a right to have **personal data** about them held by the college erased only in the following circumstances:
- Where the **personal data** is no longer necessary for the purpose for which it was originally collected.
 - When a **data subject** withdraws consent – which will apply only where the college is relying on the individuals consent to the **processing** in the first place.
 - When a **data subject** objects to the **processing** and there is no overriding legitimate interest to continue that **processing** .
 - Where the **processing** of the **personal data** is otherwise unlawful or it is necessary to erase the **personal data** to comply with a legal obligation.
- 11.14 The college is not required to comply with a request by a **data subject** to erase their **personal data** if the **processing** is taking place:
- To exercise the right of freedom of expression or information
 - To comply with a legal obligation for the performance of a task in the public interest or in accordance with the law
 - For public health purposes in the public interest
 - For archiving purposes in the public interest, research or statistical purposes
 - In relation to a legal claim.
- 11.15 If the college has shared the relevant personal data with any other organisation then we will contact those organisations to inform them of any erasure, unless this proves impossible or involves a disproportionate effort.

Right to Data Portability

- 11.16 In limited circumstances a **data subject** has a right to receive their **personal data** in a machine-readable format, and to have this transferred to other organisation. If such a request is made then the DPO must be consulted.

12 Data security

- 12.1 We will take appropriate security measures against unlawful or unauthorised processing of **personal data**, and against the accidental loss of, or damage to, **personal data**.

- 12.2 We will put in place procedures and technologies to maintain the security of all **personal data** from the point of collection to the point of destruction.

- 12.3 Security procedures include:

- **Entry controls** for accessing the building. Any stranger seen in entry-controlled areas should be reported to a member of Senior Leadership.
- **Secure lockable desks and cupboards.** Desks and cupboards should be kept locked if they hold confidential information of any kind.
- **Methods of disposal.** Paper documents should be shredded. Digital storage devices should be physically destroyed when they are no longer required. IT assets will be disposed of by Dataspire in accordance with the Information Commissioner's Office guidance on the disposal of IT assets.
- **Equipment.** Data users must ensure that individual monitors do not show confidential information to passers-by and that they log off from their PC when it is left unattended.
- **Working away from the college premises – paper documents.** If staff take paper documents from the premises, they must be kept with the member of staff at all times and not be left unattended. Once the paper copies have served the purpose for which they were taken they must be returned to the college and stored securely or shredded.
- **Working away from the college premises – electronic working.** If staff are working on electronic systems to access student information away from site this information should not be left unattended. If taken away on USB or other portable device the file must be password protected and not left unattended.
- **Document printing.** Documents containing **personal data** must be collected immediately from printers and not left on photocopiers.

- 12.4 Any member of staff found to be in breach of the above security measures may be subject to disciplinary action.

13 Data Protection Impact Assessments

- 13.1 In certain circumstances the law requires us to carry out detailed assessments of proposed **processing**. This includes where we intend to use new technologies which might pose a high risk to the rights of **data subjects** because of the types of data we will be **processing** or the way that we intend to do so.

- 13.2 The college will complete an assessment of any such proposed **processing** and has a template document which ensures that all relevant matters are considered.

- 13.3 The DPO should always be consulted as to whether a data protection impact assessment is required, and if so how to undertake that assessment.

14 Disclosure and sharing of personal information

- 14.1 We may share **personal data** that we hold about **data subjects**, and without their consent, with other organisations. Such organisations include the Department for Education, [and / or Education and Skills Funding Agency “ESFA”], Ofsted, health authorities and professionals, the Local Authority, examination bodies, other schools, and other organisations where we have a lawful basis for doing so.
- 14.2 The college will inform **data subjects** of any sharing of their **personal data** unless we are not legally required to do so, for example, where **personal data** is shared with the police in the investigation of a criminal offence.
- 14.3 In some circumstances we will not share safeguarding information. Please refer to our Child Protection Policy.

15 Data Processors

- 15.1 We contract with various organisations who provide services to the college, including:
- Strictly Education
 - SPIE
- 15.2 In order that these services can be provided effectively we are required to transfer **personal data** of **data subjects** to these **data processors**.
- 15.3 **Personal data** will only be transferred to a **data processor** if they agree to comply with our procedures and policies in relation to data security, or if they put in place adequate measures themselves to the satisfaction of the college. The college will always undertake due diligence of any **data processor** before transferring the **personal data** of **data subjects** to them.
- 15.4 Contracts with **data processors** will comply with Data Protection Legislation and contain explicit obligations on the **data processor** to ensure compliance with the Data Protection Legislation, and compliance with the rights of **Data Subjects**.

16 Images and Videos

- 16.1 Parents and others attending college events are allowed to take photographs and videos of those events for domestic purposes. For example, parents can take video recordings of a college performance involving their child. The college does not prohibit this as a matter of policy.
- 16.2 The college does not however agree to any such photographs or videos being used for any other purpose, but acknowledges that such matters are, for the most part, outside of the ability of the college to prevent.
- 16.3 The college asks that parents and others do not post any images or videos which include any child other than their own child on any social media or otherwise publish those images or videos.
- 16.4 As a college, we want to celebrate the achievements of our pupils and therefore may want to use images and videos of our pupils within promotional materials, or for publication in the media such as local, or even national, newspapers covering school events or achievements. We will seek the consent of pupils, and their parents where appropriate, before allowing the use of images or videos of pupils for such purposes.

16.5 Whenever a pupil begins their attendance at the college they, or their parent where appropriate, will be asked to complete a consent form in relation to the use of images and videos of that pupil. We will not use images or videos of pupils for any purpose where we do not have consent.

17 **CCTV**

17.1 The college operates a CCTV system. Please refer to the college CCTV Policy.

18 **Changes to this policy**

We may change this policy at any time.

An amended policy will be displayed on the college website.

ANNEX- DEFINITIONS

Term	Definition
Data	is information which is stored electronically, on a computer, or in certain paper-based filing systems
Data Subjects	for the purpose of this policy include all living individuals about whom we hold personal data. This includes pupils, our workforce, staff, and other individuals. A data subject need not be a UK national or resident. All data subjects have legal rights in relation to their personal information
Personal Data	means any information relating to an identified or identifiable natural person (a data subject); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that natural person
Data Controllers	are the people who or organisations which determine the purposes for which, and the manner in which, any personal data is processed. They are responsible for establishing practices and policies in line with Data Protection Legislation. We are the data controller of all personal data used in our business for our own commercial purposes
Data Users	are those of our workforce (including Governors and volunteers) whose work involves processing personal data. Data users must protect the data they handle in accordance with this data protection policy and any applicable data security procedures at all times
Data Processors	include any person or organisation that is not a data user that processes personal data on our behalf and on our instructions
Processing	is any activity that involves use of the data. It includes obtaining, recording or holding the data, or carrying out any operation or set of operations on the data such as collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction. Processing also includes transferring personal data to third parties
Special Category Personal Data	includes information about a person's racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, physical or mental health or condition or sexual life, or genetic or biometric data
Workforce	Includes, any individual employed by the college such as staff and those who volunteer in any capacity including Governors.
